On 1 April 2013, we requested a five (5) days extension of time to file our reply as well as (5) days or until 7 April 2013 within which to file an amended GIS to correct said the deficiencies.

In your letter, you informed us that the following were not indicated in the company's 2012 GIS:

- 1. Independent Directors
- 2. Top 20 Stockholders
- 3. Type of License/Registration
- 4. Date of Issuance of the Secondary License
- 5. Date started operations
- 6. Total Annual compensation of Directors During the Preceding Fiscal Year

You also mentioned that the number of Directors/Officers is not consistent with the Articles of Incorporation.

We give our reply as follows:

- 1. Independent Directors: In the original GIS filed on 28 June 2012, you will observe that we had marked with asterisk and supplied a corresponding footnote for the independent directors on page 3. We should have indicated "I" for independent directors instead. Please see our correction in the Amended GIS attached hereto.
- 2. Top 20 Stockholders: In our original GIS filed on 28 June 2012, you will observe that a one page list of the company's Top Twenty Stockholders was made as a separate attachment to the GIS. We will again attach a copy of the said List in the Amended GIS attached hereto for your ready reference.
- 3. Type of License/Registration: APC Group, Inc. is a holding company. Accordingly, it has no secondary license. We believe the false impression is created by the term 'financial intermediary' indicated in the industry classification. We will rectify this in the attached amended GIS by indicating 'holding company' in the industry classification box and by attaching a separate sheet containing the primary purpose of the Company.
- 4. Date of Issuance of the Secondary License: As stated in number 3 above, the company has no secondary license.
- 5. Date started operations: The Company reckons this from the same date as that of the registration stated in the original GIS which is 15 October 1993.
- 6. Total annual compensation of Directors During the Preceding Fiscal Year: We have indicated a total compensation of P1,980,000 on the amended GIS attached to this letter.

On the alleged issue of inconsistency of the number of directors/officers with the Articles of Incorporation, we maintain that as of the date of the filing of the original GIS, the Articles of Incorporation (as last amended on 13 October 2011) provided for eleven (11) directors. It was only on 14 December 2012 that the amendment to Articles VI of the Articles of Incorporation was approved by the SEC effectively reducing the number of director to seven (7).

For your ready reference, we attach a copy of both the original 2012 GIS filed on 28 June 2012 and the Amended 2012 GIS containing the desired corrections.


