- The Company has filed the Income Tax Return with the BIR last April 13, 2015 through the e-Filing and Payment System (eFPS) but on April 14, 2015 as we were accessing the BIR website to pay for the income tax due, the BIR website/system crashed. The eFPS is not yet working up to now.
- BIR did not permit us to pay manually for the tax due since according to them, the payment should be made through the eFPS since we have already submitted the ITR through the said system. They informed us that they will release a memorandum tomorrow, April 16, for instructions but it will be too late to file the 17-A within the prescribed period.
- Due to non-payment, BIR will not receive APC Group, Inc.'s parent Financial Statements therefore
 the Parent FS and the 17-A cannot be also filed with the Securities and Exchange Commission,
 hence this request for extension.
